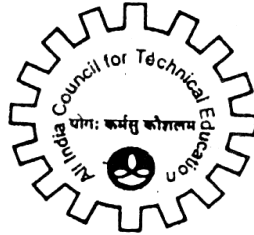

Private – Grant in Aided	In this regard, we wish to bring to your kind attention that our Institution is a GOVERNMENT AIDED one which has been functioning from 1968 and has been approved for the purpose of Aid by the Director of Collegiate Education (Proceedings RC No. 77999/32/69 dated 7.10.69). The institution has been receiving aid from the Government of Tamilnadu for all the courses (UG and PG including Master of Computer Applications(started in 1988-1989) (copy enclosed) (GRANT-IN-AID)
2.	Faculty (a) Principal / Director is not eligible as per AICTE norms. Principal experienced and qualified as per AICTE norms is to be recruited. Separate Director is not available for MCA institution	As for as the nomination of the Principal is concerned, we are to clarify that the present incumbent has put in more than Two decades of service with good administration and academic record. He is also qualified and experienced as per AICTE norms (Ph.D. Holder). Moreover, the appointment of Principal was done after taking into consideration of various aspects

		and the present incumbent has been appointed based on the merit and as per the guidelines laid down by the authorities. As per Government of Tamil Nadu norms there is no provision for appointing separate Director since it is an <b>GRANT-IN-AID course. Principal will be the Director.</b>
	(b) 6 Faculty members are with MSC. (Specialization not known) with PGDCA. Out of the 5 qualified faculties 2 are on ad-hoc basis. Exclusive faculty qualified as per AICTE norms should be recruited.	With regard to appointment of faculty, we wish to inform that the regular faculty for the department were appointed between 1986 and 2000 as per the then existed government norms and university guidelines. Out of the eight regular staff members five of them are having M.C.A., M.Phil., qualification meant for M.C.A., course, seven have put in more than ten years of service and qualified for M.Phil degree. Though the state government stopped giving approval for regular appointments, the management of the Institution appointed three more lecturers with M.C.A., M.Phil., as per the University prescribed qualifications, thereby making the department a full pledged one. Moreover, the course has been accorded and approval by the AICTE since 1995, with the same faculty members on the roll.
	(c) AICTE pay scales with prescribed DA are to be implemented for all the faculty members.	As for as the AICTE pay scale is concerned, we are to clarify that the course is run by receiving aid from the Government of Tamilnadu and the regular teachers are being paid with UGC scale of pay which is either on par with or more than the AICTE scale of pay.
3	Books	During this academic year the Management will provide necessary fund to the Department of Computer Science for purchase of required Number of books according to the current demand.
4	Others: Placement cell needs to be strengthened and should play an active role in providing placements.	The institution has an active placement cell with full-time Placement Officer. **13. Strengths & Weaknesses of the institution in terms of Teaching Methodology/Transaction of Syllabus / Innovations / best practices (if any) / industrial project / Industrial consultancy / research taken up for industry and amount granted thereby:**

In addition to the “talk and chalk” method for teaching assignments, seminars, guest lecturers are arranged using the various audio visual aids. The syllabus is updated every year to include the latest subjects which offer high employable potential for the students. Alumni regularly interact with the students about needs of the industry.

To increase the employability of the students, aptitude tests are conducted on all working days. GDs and mock interviews are also conducted.

The students have a large number of practical papers (two practical papers per semester). They also undergo two mini projects in the Second and Third year of study to get them a first hand experience in software development. In the sixth semester, students undergo project training of six months duration in reputed companies.

In the first year, Students learn “Communicative English” as an additional paper for improving the communication skills.

Extra credit course on “Hardware Maintenance & Troubleshooting”, “Network Maintenance & Administration”, “Internet & Web Page Design”, “Flash” and “Photoshop” are offered by the Department.

Institution develops software for its needs. The Examination work, Office work, College website, Online testing software, Library management software and student counselling and admission software have been developed by our M.C.A. Students.

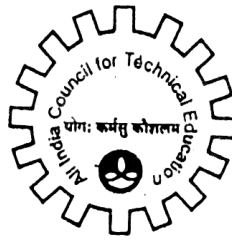

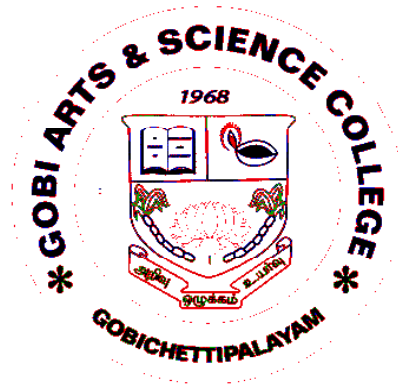
